#### 4.3 2019 CITIZEN OF THE YEAR AWARD – YOUTH

#### **Category Criteria**

This category recognises personal endeavour, achievement and worthwhile community input from individuals under the age of 25 years.

To be eligible, the person must be an Australian Citizen, under 25 years of age and resident within the Town of Cottesloe or work/participate in the Town of Cottesloe district.

In addition to the usual gifts/certificates provided to award winners, Council will contribute to a maximum of \$2,000 to this award winner for a personal or professional development program that will benefit the winner's long term career aspirations i.e. a trip on the STS Leeuwin or a contribution to study fees.

#### Attachments: Volunteer Recognition Awards Policy

At a meeting of the Public Events Committee in May 2018, the need for a policy to provide guidelines for the Volunteer of the Year Award was discussed. At this meeting it was agreed that staff would prepare a draft policy for consideration of Council.

Previously there has been no policy to guide the Public Events Committee in making a recommendation to Council for the Award, although there were some brief guidelines on the nomination form used (see attached).

The Public Events Committee were of the view that there was an overlap between the Australia Day awards and the Volunteer awards and that the Volunteer awards should be for individuals only, not community organisations who have their own specific category in the Australia Day awards.

The Policy does not reference the service award provided to former Elected Members, which should be a separate Policy. It is suggested that it may be advantageous to separate the service awards to elected members from the volunteer event and awards and possibly present these at the Annual Electors Meeting.

The Draft Policy will be presented to the December 2018 Ordinary Meeting for consideration by Council, subject to feedback received from Committee members.
