# SUMMARY

The Committee is requested to endorse the proposed blister island design at Marine Parade/Gibney Street.

# BACKGROUND

At the February 2018 Committee meeting, the Committee discussed options for the blister island at length. The following is a summary of the conversations held:

Mrs Tyler-Hare advised the Committee that comments have been received. Mr Woodhouse indicated that a plateau is not a preferred option as it is a danger to pedestrians as there is uncertainty between traffic and pedestrians. Mrs Tyler-Hare suggested that footpaths could be graded down so it is flush. Cr Pyvis raised concerns that this would allow traffic to speed through the area. Cr Sadler commented that pedestrians should be prioritised and they shouldn't be at the same level as cars.

Mrs Tyler-Hare queried the use of a zebra crossing. Mr Humfrey indicated that this does not meet Main Roads Western Australia requirements and that there are concerns for line of sight.

*Cr* Young noted that the noise made by vehicles needs to be considered. Mr Humfrey indicated that people would slow down and then accelerate creating additional noise.

Cr Boulter suggested approaching Main Roads Western Australian for comments. Cr Young suggested looking at the Wearne Masterplan. Cr Sadler raised concerns regarding the on/off road cyclist ramps as they create too many pedestrian conflicts.

Cr Sadler's attached email dated 5 January 2018 was noted. Point four to install an ACROD bay will be provided to the Disability Services Advisory Committee for comment.

*Cr* Boulter asked if there would be additional lighting installed at the proposed blister island. Mrs Tyler-Hare referenced point 1 on the plan which shows this already being included.

Mrs Tyler-Hare advised the Committee that the requested changes would be provided to the Town of Nedlands and the updated document will be provided to the Bike Planning Committee for further consideration.

Cr Boulter thanked Cr Sadler and Cr Pyvis.

Subsequent to this, the following actions and outcomes have been undertaken and arisen:

- 1. The Wearne Masterplan has been reviewed, and there are no vehicle access points at the proposed blister island location;
- 2. The following changes were requested to the City of Nedlands:
  - a. Remove the pram ramps and include a raised plateau across the road.
  - b. Confirm that this can allow cycling without age bikes to get across safely.
  - c. Remove the off-road cyclist option.
  - d. Include two trees at either end of the blister island.
- 3. The City of Nedlands have advised the following:
  - a. They have checked the Main Roads standard drawing for a flat top plateau and note 4 of the drawing states that Main Roads does not support road humps as pedestrian crossings unless they are wombat crossings. The City is in agreement with Main Roads' position on this as we believe that the piano markings on its own create confusion between pedestrians and vehicles as to who has priority.
  - b. Additionally, the City of Nedlands does not support:
    - i. The removal of the off-road cyclists option The blister island will create a squeeze point for on-road cyclists which is a hazard.
    - ii. The addition of trees in the blister island Trees can be both a road side hazard and an obstruction to clear sight lines. The required clear zone for the crossing location is 5m (see MRWA Supplement to Austroads Guide to Road Design-Part 6 Clause 4). Issues surrounding trees being road side hazards and potentially creating sight line issues are also highlighted in the Austroads Guide to Road Design Parts 6A (Table 4.3) and 6B (Cl. 3.4.4).

# **STAFF COMMENT**

The City of Nedlands does not support a raised plateau without line markings, such as those found on the attached wombat crossing. If a wombat crossing was to be installed, it would address the Committee's concerns with providing an at-grade crossing, and a sufficient width for cycling without age crossings.

The Town agrees with the City of Nedlands that trees may cause sight distance obstructions, and recommend not planting trees at this stage. This could always be revisited in the future, once the blister island is installed and in operation.

The issue at hand comes down to two competing objectives; the ability to provide a safe crossing Wearne citizens, and the ability to allow cyclists to continue to use Marine Parade as they would normally.

A possible compromise is to install green cycle lanes on road, to provide cyclists with a safe option, and change the footpaths so that they grade down at a very small slope to match the road level. This provides the Wearne citizens an at-grade crossing, with a refuge in the middle, providing them with improved safety in crossing.

However, leaving out a wombat crossing means cyclists are not impeded by this, but still have a safe route through the blister island. An alternative concept is attached pertaining to this compromise, which shows the blister island being 2.5m wide. This could be increased to 3.2m, by slightly realigning the footpath to be flush with the Wearne boundary by 300mm, and reducing the footpath width at this location from 2.2m to 1.8m.

The Town has spent a considerable amount of time on this project, and would like to see it finalised, with a compromise that meets both user group's needs, as well as the general traffic.

The Committee noted the email Mr Powell sent on 7 May 2018 – Reduction of speed limits in Cottesloe (Marine Parade and Town Centre).

The Committee noted the email Cr Sadler sent on 6 May 2018 – Foreshore Masterplan Workshop.

Mr Powell advised that Marine Parade is a critical area for cyclists. He indicated that his preference for the area would be a separate pedestrian promenade and cycle path. Alternatively, traffic should be slowed and a wide shared path for cyclists and pedestrians be created. The shared path would need to be wider than a Principal Shared Path. Mr Atkinson agreed with Mr Powell's suggestions.
