SUMMARY

The Town has undertaken community consultation on the suggestion to enclose or separate the playground at Jasper Green from the dog off-lead area. The results are presented as per the attached summary, and the Committee will be asked to recommend not fencing the playground.

BACKGROUND

An action item from the Reserves, Parks and Playgrounds Committee was to undertake consultation on the fencing/separation of the playground at Jasper Green Reserve.

The survey was opened on 10 October 2018, and closed on 5 November 2018. There were 80 responses in that time, with 61 percent of respondents using the park daily.

STAFF COMMENT

Out of the 80 submissions received, 70 (87.5 percent) would not support a physical separation between the playground and the dog off lead area. 65 (84.42 percent) have a preference for option 3 – leaving it as it is, and 64 (83.12 percent) support no barrier.

Due to the overwhelming response indicating a 'do nothing' option, it is the administration's recommendation to leave the reserve as is, with no fencing or barriers separating the playground and dog off lead area.

SUMMARY

The Committee is asked to consider a Council recommendation to approve a budget amendment of \$29,793.23 and to award of the Public Open Space Master Plan Consultancy to UDLA

BACKGROUND

At the October 2018 Committee Meeting, the Committee recommended that additional time be allowed to source additional quotations for the consultancy works with only one submission received from UDLA during the initial procurement process.

A second offer, jointly submitted by Ecoscape and Element has been received in the subsequent Request for Quotation. Playright have declined the opportunity to provide a bid.

- See opportunities to augment local passive public open space within the developed suburban areas and larger development sites.

The remaining Public Open Space Masterplan budget of \$17,506.07 is insufficient to accept the UDLA's quote. A budget variation of \$29,793.93 that includes contingencies will be required. The additional funds will be sourced through a budget transfer from the following accounts:

30.1060.2 Eric St/Curtin Ave Park Fencing \$17,000.00 30.9000.2 Various Playground Construction \$12,793.93

Council has previously resolved not to proceed with the Eric Street and Curtin Avenue Park Fencing. Approximately \$397,207 remains for the construction of various playgrounds following the transfer of \$12,793.93.

STAFF COMMENT

Both quotations received demonstrated significant relevant experience together with a well detailed methodology, illustrating an in depth understanding of the project requirements.

However, UDLA's offer best demonstrates value for money when both the qualitative and quantitative criteria are taken into consideration.

Due to the nature of the project, staging of the works to suit available funds would not be possible. The proposed additional funding sources are from related project budgets that are either no longer required or associated with the construction of the playground upgrades identified within the Master Plan.
