#### BACKGROUND

At the March 2018 Committee meeting, the Committee discussed the possibility of the incorporation of a street/location reference at beach access path number locations.

At the May 2018 Committee Meeting, the Committee resolved:

That the Committee:

- 1. ENDORSE the use of a small circular sign at the base of the stairs noting the beach access path number and location; and,
- 2. ENDORSE the inclusion of a street or beach name.

Further to this resolution, a proposed list of names, in consultation with Cr Pyvis, and Jack Walsh had been prepared.

The workshop held on 8 October 2018 was attended by:

A presentation was made to the attendees on paths S0, S8, S12 and N8, followed by a discussion that generated the following themes towards developing the names for the four paths:

- History and connection to Rottnest;
- Ocean;
- Fish dolphins, food, shark, whale, starfish, crayfish, seahorse, abalone;
- Sunset/sunrise;
- Morning star;
- Seasons summer;
- Water;
- Birds seagull, heron;
- Sand;
- Land;
- Pathways;
- Dreamology;
- Environment;
- People; and,
- Senses sight and sound.

Further discussions narrowed the above list to six key themes below. Names associated with each category were then identified and voted upon.

- 1. Birds
  - a. Pacific Heron Jili (3)
  - b. Sea eagle Narloo (2)
  - c. Eagle Waldja (0)
  - d. Seagull didjinig(3)
- 2. Summer birrdag (4)

- 3. Ocean woordarn (5)
- 4. Fish
  - a. Tiger shark Moondo (5)
  - b. Grey nurse shark margid (1)
  - c. Whale mamang (3)
  - d. Seal balgardv (0)
  - e. Dolphin gwilyinya (2)
- 5. Environment
  - a. Sea breeze marr golying? (4)
  - b. Morning star birrn (6)
  - c. Sunset wooralo (3)
- 6. Sight and Sound
  - a. Healing Walbirriny (5)
  - b. Looking over Woorl-bo-djinanginy (3)
  - c. Gently/going slowly dhabakarn (2)
  - d. Sound Myi (4)

The workshop attendees then agreed that the above was to be further eliminated by shortlisting names that only received four or more votes. This resulted in the following seven most popular names within the five categories being recommended for the committee's consideration.

- 1. Summer birrdag (4)
- 2. Ocean woordarn (5) (story around the Father Ocean)
- 3. Fish
  - a. Tiger shark Moondo (5) S0
- 4. Environment
  - a. Sea breeze marr golying? (4)
  - b. Morning star birrn (6)
- 5. Sight and Sound
  - a. Healing Walbirriny (5)
  - b. Sound Myi (4)

It was also suggested that the story associated with the naming of these four beach access path be placed on the proposed signs. This can be incorporated at the detailed design stage of each sign.

The Foreshore Precinct Implementation Committee has indicated the preference to maintain the word 'street' for paths named after each street.


#### **OFFICER RECOMMENDATION**

#### 8.2 Beach access path – South of Barchetta

The Committee advised they agree with point c below and requested that the Beach Access Path Committee consider access in future planning.



The community has suggested the removal of the log step ladder to avoid Ocean Beach Hotel patrons from using this as a shortcut to access the beach. This request has been annotated as follows:

Immediately south of Barchetta there is a log stepped path from Marine Pde to the lower path. Its main function seems to be to facilitate the short cut by the happy drinkers from the OBH to get to the beach by jumping the fence.

I think this path could be removed without any loss of amenity, and that area of the foreshore planting unified.

The administration has reviewed this and notes the following:

- a) The log ladder facilitates access from the car park at Barchetta down to the lower path, without having to zigzag down.
- b) The main concern appears to be with the ease at which people can jump the fence onto the beach.
- c) In lieu of removing the log ladder, a more appropriate solution would be to revegetate the area directly opposite the ladder between the beach and the fence, and possibly increasing the fence height.
- d) As this is a beach access path, it appears to be within the beach access path committee's purview; however it also falls into the area where the masterplan will extend to. As a result, we propose that each committee reviews the recommendation to revegetate and improve the fence, and provide a direction for the Administration to progress. The Town will review to determine the way forward and whether further Committee or Council input is required.
