

#### 1. Citation

This local law may be cited as the *Town of Cottesloe Dogs Amendment Local Law 2012*.

#### 2. Commencement

This local law comes into operation 14 days after the date of its publication in the *Government Gazette*.

#### 3. Principal Local Law

In this local law, the *Town of Cottesloe Dogs Local Law 2011* published in the *Government Gazette* on 26 July 2011is referred to as the Principal Local Law. The Principal Local Law is amended.

#### 4. Clause 1.4 amended

In Clause 1.4 insert the following in alphabetical order:

Children's playground means an area set aside for use by children and noted by the presence of dedicated children's playground equipment and the presence of either white sand or other form of soft fall surface;

#### 5. Clause 4.1 amended

Clause 4.1 (1) is amended as follows -

- (a) In paragraph (c) delete "2008," and insert "2008;";
- (b) In paragraph (d) delete "pool," and insert "pool;"; and
- (c) In paragraph (f) delete "designated by sand/soft fall area or fence".

#### 6. Clause 4.2 amended

In clause 4.2 -

- (a) delete subclause (3):
- (b) delete subclause (4); and
- (c) delete subclause (5).
