Dear Kevin

As I am sure you are aware, the extensions to our building are rapidly drawing to a conclusion. We anticipate practical completion by the middle of May.

The completion of this project will add significantly to the amenity of the North Cottesloe beach area, in particular:

- The dual use pathway will now confirm to the Australian standard providing universal access to the beach for the first time,
- The dune immediately in front of and to the north of the club rooms will feature Cottesloe native
 vegetation and be extensively landscaped providing improved dune stability, less of a home for
 dugites and rabbits, and a more pleasant view,
- The grassed area to the north of the club will be completely replaced including landscaping to the edge of the pathway and a new limestone stepped area to link the grassed area with the dual use pathway, and
- The dual use pathway is realigned to reduce hazard at the juncture with the club rooms by improving the line of sight.

The project has not been without its challenges however. Whilst we have generally remained within our budget, the requirements to engineer a fire protection solution for the site have proved to be a major concern for the Club. You may recall that the project was delayed by over 12 months as additional land was secured for the lease to allow the installation of tanks, pumps and generators for a fire fighting solution. The engineering of this solution was a prerequisite of obtaining a building license and the commencement of construction. Since that time, the Club and its consultants have investigated alternative means of achieving a fire protection solution. The optimum solution is to have the water mains upgraded to provide adequate water pressure to meet legislative requirements. The Club is pursuing this solution with the Water Corporation. It should be noted, that all of the commercial facilities in the North Cottesloe node are currently under serviced from a fire protection perspective, and as such any solution achieved by the Club will be to the benefit of all commercial and residential buildings in the area.

The additional costs that have already been expended in providing the space required for the tanks and pumps totals some \$360,000. This additional expenditure was unbudgeted and has now forced the Club to compromise on other areas of the build. In particular, we are considering reducing the expenditure on landscaping in the public areas to enable the building itself to be completed. Should this occur, the costs to complete the landscaping at a later date will necessarily be higher as the builder will be required to remobilise to site and undertake these works as a separate project. From a visual perspective, it would also be a shame to see these works incomplete.

I am therefore, reaching out to Council with a request to assist the Club financially as it completes the project, in particular to assist with the funding of the landscaping being undertaken in the public open space. The total cost of the works being undertaken in the public open space total in excess of \$250,000. The Club has always considered that it has been spending above and beyond the requirements of a tenant on these lands. The particular expenditure that must be focussed upon are:

- 1. The new limestone steps linking the grassed area with the dual use path
- 2. The limestone walls retaining the land above the dual use path
- 3. The dual use path itself, and
- 4. The repair of the dune in front of the dual use path.

The Club has estimated that it could save some \$50-75,000 by not building the limestone steps and by completing the rest of the works to a minimum but safe standard. The financial assistance of Council to complete these works in the public open space (that is, on Council land) would provide real amenity to the local population and not just to the Club and its members.

I am hoping that Council will consider this request for a modest financial contribution of \$75,000, favourably enabling the completion of the project for the improved amenity of all residents of Cottesloe.


