## **DOG OWNER'S RESPONSIBILITIES**

The Dog Act 1976 states dog owners must ensure their dog:

- Wears a collar displaying owner's name, address and council registration tag when in a public place.
- Is microchipped and registered with the Local Authority once they reach three months of age. Failure to comply may lead to penalties.
- Is under the control of a competent person on a maximum two-metre lead when in a public place.
- Is exercised off a leash in designated areas only, with the person in control carrying a leash to ensure the dog can be restrained, if required.

## **IMPORTANT INFORMATION**

- The Town MUST be notified immediately of any change of particulars contained in this application, including change of ownership, address, or the death of a dog.
- Dog registrations expire on 31 October each year (as from 1 June each year, half the normal fee will be applicable to FIRST annual registrations only).

## **FEES PAYABLE**

- Registered veterinary surgeon's certificate or statutory declaration must be provided for the sterilised fee to be charged.
- Reduced fees apply upon proof of current:
  - Pensioner Concession Card.
  - > State Concession Card.
  - > Commonwealth Seniors Health Card together with Senior Card.
- Gold Cards or Healthcare Cards are not acceptable.
