

# APPLICATION FOR ASBESTOS REMOVAL

## THIS FORM MUST BE COMPLETED IF APPLYING FOR A DEMOLITION PERMIT WITH A PROPERTY CONTAINING ASBESTOS AND/OR ASBESTOS MATERIAL

This application is designed to correctly identify and safely manage asbestos removal as part of a building demolition process. The necessary work precautions to be adopted in the asbestos removal process vary, depending on the type and quantity of asbestos, its condition, age and location.

It is requested that the applicant complete the form and submit it to [town@cottesloe.wa.gov.au](mailto:town@cottesloe.wa.gov.au) along with a copy of;

- an asbestos removal management plan;
- a copy of notification letter to be sent (by the demolition company) to affected properties within a 50m radius;
- copies of asbestos removal licenses and;
- details of proposed signage to be located onsite

<b>PRIOR TO REMOVAL</b>		
Completed form and supporting documentation has been submitted to the Town's Compliance and Regulatory Services		
The Town's Compliance Officer will be notified on 9285 5000 or at <a href="mailto:town@cottesloe.wa.gov.au">town@cottesloe.wa.gov.au</a> at least 48 hours prior to commencing demolition of buildings containing asbestos.		
Neighbouring residents within a 100m vicinity of the site must be notified 5 days prior to asbestos removal.		
The property will have signs and barriers erected to warn that 'asbestos removal is in progress', and to prevent unauthorised persons from entering. Details of proposed signage to be submitted with this application.		
<b>FOLLOWING REMOVAL</b>		
All asbestos must be removed from the site prior to commencing any further works.		
All waste containing asbestos shall be labelled with the words CAUTION ASBESTOS in 50mm high letters and disposed of at an approved landfill site in accordance with the <i>Environmental Protection (Controlled Waste) Regulations 2004</i> .		
All asbestos shall be taken to an approved site, and a copy of the disposal receipt forwarded to the Town's Compliance and Regulatory Services within 48 hours of disposal.		

## DECLARATION

I have read and understand the requirements for safe handling, removal and disposal of asbestos as set out in the *Occupational Health and Safety Act 1984*, *Occupational Safety and Health Regulations 1996*, the *Health (Asbestos) Regulations 1992* and the National Code of Practice for the Safe Removal of Asbestos. I understand the requirements placed upon me for the safe removal of asbestos by the *Environmental Protection (Controlled Waste) Regulations 2004* and understand that I must take all reasonable measures to ensure asbestos is handled safely. I understand that if I fail to comply with the above requirements, I will be committing an offence and may be required to take appropriate remedial action, and may be prosecuted.
