Cat Registration Application Form



Western Australia's *Cat Act 2011* requires:

- cats aged six months and over must be registered
- proof of the cat being sterilised and micro chipped, for example sterilisation certificate or itemised vet bill, must be shown
- you must inform the city immediately of any change in ownership, the death of the cat and any change in address

Upon completion and lodgement of this form, and receipt of the correct registration fee, your cat will be given provisional registration and a tag. Upon successful registration you will be issued a certificate of registration by mail. Penalties apply for failing to renew your cat registration(s). If you move to another district, you are required to notify and register the pet with the new local government, however no further fee is payable for that registration period.
