#### **Additional Information**

Why I am running

I am motivated to stand because of concerns with council decisions to proceed with proposals that have not been first exposed to community scrutiny, or not exposed early enough, or with sufficient information, for this public scrutiny to detect mistakes before they happen. Improving this process will deliver better outcomes for everyone and help overcome any hidden agenda.

Prior community consultation would have detected safety issues from a decision on where to re-locate the Anderson pavilion. Costs were wasted on repeated proposals for new beachfront toilets anywhere but where belated consultation show they are most wanted, which is to replace those under Indiana. Locals have still not had a say on 4 years of council resources used on a lessee proposal to redevelop, rather than on any alternate plan for new changerooms/toilets and better activate Indiana surrounds as public open space not as private hotel rooms.

Consultation on Marine Parade as a primary bike path did not say it would be on the foreshore path rather than the road. Consultation on its design did not say it may be expected to include endless poles, all-night lighting, similar to the path beside the rail, or that at the main beachfront riders join vehicles in a free-for-all on a reduced width Marine Parade.

Contrary to strong community support, council removed a long-held objective to 100% connect Cottesloe by sinking the rail and re-aligned Curtin Avenue, and now appears to favour lifting the rail, and presumably the adjacent bike path, so bikes not just trains can speed through Cottesloe, at rooftop level of houses and the town centre, doing little to overcome barriers for everyone else.

My other priority is to fix the main beachfront, not just new changerooms and toilets. Its upkeep was put on hold in the hope funding eventuates for its upgrade, but hope is not a strategy. Its time to fix what we have, potholed carpark 1, bare lawns, unkempt terraces and rusty handrails
