<p>Attention Ms Parshia Queen Re Feedback on proposed changes to parking restrictions on Vera St Cottesloe</p> <p>We agree that the proposed changes to the proposed change of extending the yellow line would help in addressing safety, however, I believe it is going to further restrict parking by residences and visitors in the street and add to the congestion that already exists.</p> <p>The street is used as a short cut by drivers wanting to avoid traffic lights and it is worrying to see the speed of vehicles in attempt to save time to their destinations. There is no footpath on the street and no choice for pedestrians other than to walk on the road and get off when a car comes. A huge safety matter particularly with children, elderly and PLC students who live or walk on Vera Street. I believe the parking restrictions would mitigate any potential risks of a serious accident. Vera street is narrow so in order to avoid a car parked, a vehicle must enter oncoming traffic. <p>We refer to you letter dated 2 August regarding proposed parking restrictions in Vera Street.</p> <p>We wish for the proposed restrictions to be withdrawn for the following reasons:</p> <ol style="list-style-type: none"> 1. The proposed restrictions are not a solution to the issue raised being the hazard of turning into Vera Street from Stirling Highway. 2. Vera street is being used as thoroughfare for traffic from Stirling Highway to Railway Parade. This is not the use it was designed for. 3. The neighbouring street – Forrest Street – is a commercial street and a double width street however is blocked from turning off from Stirling Highway. As a consequence of this much wider, busier street being blocked off, traffic is redirected to Vera Street which is a narrow, single width residential street. 4. There are significant numbers of cars each day using Vera Street to access the business’s on Forrest Street. The fact that this wide, commercial street is blocked to the highway but the narrow, residential Vera Street is accessible from Stirling Highway is a clear indication that a full review of the flow of traffic in the area needs to be completed, not just a quick fix solution sought. 5. The opening of Vera to Stirling Highway is 13.7m whilst the opening of Forrest Street to Stirling Highway is 31.5m. Vera street is 5.1m wide whilst Forrest Street is 8.1m wide. Given the differing widths of these neighbouring streets, the their use as commercial v residential, it seems clear that Vera Street should be closed to incoming Stirling Highway traffic. 6. Our neighbours on the street that we have discussed this with agree that a comprehensive review needs to be completed and that an exit only from Vera street onto the Highway - whilst restricting turning into Vera Street from Stirling Highway like is in place at Boreham Street – is the ideal solution. This would make the street safer and more in keeping with its size and use whilst at the same time not overly restricting access nor causing the problem of needing a turn around if the street is fully blocked off from Stirling Highway. 7. No connection has been established between the two accidents on Stirling Highway referenced and cars that may or may not have been parked on nearby streets including Vera Street. This needs to be explored in a full review. 8. We understand that changes to traffic access in and out of Stirling Highway is not the domain of the council but the MRD but this does not, and should not, stop a complete and correct review and solution to be arrived at. A “quick fix” is not the answer to long term traffic and parking management. 9. It is our understanding the current yellow line is compliant with the Main Roads regulations. 10. Our neighbours do not wish to have parking pushed down the street to their street frontages and verges. 11. <p>We have been at the above address since 1998 & there has been a very large increase in the traffic on Vera Street particularly over the last few years. Many of the blocks on the north side were the back of the houses of Albion Street & these blocks have been subdivided.</p> <p>Consequently there have been many new houses built on the smaller blocks now on the north side of Vera Street. They all have garages but unfortunately many of them are used for storage (as with 4 Vera St) & their cars are parked in the driveways. Many of these owners or tenants have children with cars which have added to the necessity of parking in the street.</p> <p>Because of the near misses I have had at the east end of Vera St either entering or leaving the street I contacted the Council of the issue of safety. They did look at the situation & advised that to put this to Council I had to contact my east ward Councillors. I did this & Cr Michael Tucak made himself available to meet with myself & Alex Craig (14 Vera St) to discuss this matter & the problem of the pine tree.</p> <p>I do not agree with the proposed changes of extending the current yellow line as shown in the diagram as it will put more cars from the residents of the north facing houses on to the street for parking.</p> <p>I propose the 2 yellow lines to be continued in line with the driveway of 6 Vera being the east side of the over pass. This will give ample room for cars to safely exit or enter Vera Street. There are at present no parking signs for the entire south side of Vera Street.</p> <p>This is certainly a short term fix & I propose that the Council looks at it in more depth for the future to divert the traffic as it has become a race track. It is a narrow street with no footpath & used daily with PLC girls walking to the railway station. It is disappointing.</p> <p>I look forward to hearing from the Town of Cottesloe with regard to the outcome of these proposed changes.</p>	
<p>To whom it may concern,</p> <p>Parking and through traffic on Vera Street Cottesloe</p> <p>I noted in the Post Newspaper (9th August) an item suggesting that the Town of Cottesloe is considering closing Vera Street to traffic from Stirling Highway. I wish to register my concern at this suggestion for the following reasons:</p> <ol style="list-style-type: none"> 1. Vera Street is very narrow, with no footpaths on either side. Currently, all day parking is allowed on the north side of the street. 2. Given that access to Forrest Street is constrained by a traffic island on Stirling H'way, traffic wishing to access Forrest Street from the north will often use Vera Street. This does add traffic to Vera Street, but given the already 'busy-ness' of Vera street (see above) and its narrowness, traffic is generally slow. 3. There are businesses on Forrest Street which have access to Vera Street and many of the employees and clients use Vera Street making parking on the street quite difficult. <p>By closing access to Stirling Highway and using only Railway Road for ingress and egress simply pushes traffic onto other streets and further exacerbates moving around from Vera Street.</p> <p>Closing access to Stirling Highway would make it particularly difficult for larger vehicles, such as vans and trucks delivering to Vera Street to turn around to exit from the street. If Vera Street users were forced to use only Railway Road then the entrance to Vera Street would have to be altered. As it is now, the entrance is extremely narrow with limited opportunity for a car to enter the street if there is a vehicle stopped, ready to access Railway Road.
