#### 4.1 Mapping of current works and potential sites

The Committee discussed the process of identifying and selecting potential sites. A summary of issues raised follows;

- There are very few reserves left without a sculpture within the Town;
- The remaining potential sites are located within road reserves and transport corridors:
- The need to consider decommissioning some works.

ACTION: The administration will prepare a map and photo catalogue of existing works for the Committee's consideration.

#### 4.2 Development of a Public Art Strategy

The Committee discussed the process that could be undertaken to develop a Public Art Strategy, including;

- Looking at whether the document be prepared internally or with the assistance of a consultant;
- The need to look at other examples to help guide the process. Some suggestions were;
  - Waverly Council's Acquisition Strategy;
  - Universities including UWA and ECU;
  - Private collections including Westfarmers
- It was raised that the purpose of public art work is to draw people in rather than providing gallery pieces;
- Areas of movement that could be improved with artwork
- Cr Boulter's notice of motion and that it be included as a reference document for the Committee when considering the strategy.

ACTION: Committee Members to research suitable examples of a public artwork strategy and circulate them amongst the committee (admin to compile)

#### 4.3 Foreshore Rejuvenation

The Committee discussed the level of involvement they would like to have with the development of the Foreshore Master Planning process that will being later this year.

#### Moved Cr Tucak, Seconded Mayor Angers

That the Committee recommends to Council that the Foreshore Precinct Implementation Committee consider the placement of public are within the Foreshore Master Planning Brief and that the Art Acquisition Panel be consulted in this process.
