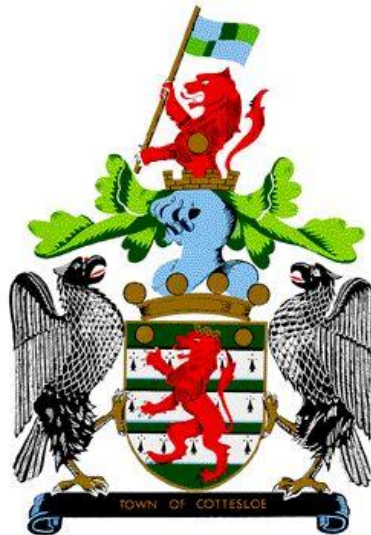

- Change paragraph 4 to the following:

The Strategy demonstrates the Town's willingness to provide leadership in the role Public Art plays in building community, public well-being and identity using:
