# responds to State on TPS3

A POSTAL poll of every Cottesloe elector, to ascertain whether retention of the 12m beachfront central height limit is favoured, is part of Cottesloe's response to State government comments on the Town's draft new **Town Planning Scheme.** 

That was one outcome of a long and detailed Council meeting, with input from concerned residents. Two important decisions were made concerning housing density, and height limits.

#### Density

Council believes that the current character of should Cottesloe be retained; but it is not adverse to increasing overall density near the Town centre. While five-storey development is not wanted on the beachfront, some increase in height limits could be considered near the railway and town centre. Staff will now report on the potential to increase population by redeveloping vacant railway

## Council LOW-RISE RULES **ON BEACH FRONT** FOUR (TPS3) – by developers who after Supreme Court vears Multiplex first applied to


rebuild the Cottesloe Beach Hotel, the Town of Cottesloe has won a Supreme Court appeal. This effectively means the end of Multiplex's appeal, to the State Administrative Tribunal, against Cottesloe's refusal to allow a six-storey development of the CBH.

The Court ruled that Multiplex's 2004 development application was fundamentally flawed and cannot approved be under Cottesloe's Town Planning

land, as opposed to increasing density in small pockets of Cottesloe.

#### Height

Staff will also report on the pros and cons of increasing height along Marine Parade. Subject to Council signing-off on the content of that report, a postal poll of Cottesloe electors will then be conducted. Cottesloe will then go back to the WA Planning Commission and report on the wishes of local community.

#### Low-rise victory

"This judgment is a victory for grass-roots, community aspirations for a lowrise Cottesloe beachfront," said Mayor Kevin Morgan.

"It thwarted the big-endof-town's attempt to use clever legal reasoning to side-step the height limits that are so treasured by the community.

Fight continues

Although the community has won today's battle, there is still a long way to go in winning the overall war, said the Mayor.

The original temporary closure of Jarrad St across the Sea View golf course was for four years and time's up next month. After respondents overwhelmingly supported permanent closure (September 2006: 499 for, 14 against) the WA Planning Commission has been unable to support the permanent closure of the road despite unanswered invitations to come down to Cottesloe and gain firsthand knowledge of the Town's safety concerns. So, with no chance of a timely response, the Town needs to make another 'temporary' closure and this time its for 21 years. Despite the overwhelming sentiment expressed by respondents last year, the Town must again request public comments on the proposed temporary closure. Please voice your comments by 6th July 2007.

But Council has made a proviso. Before committing funds Council wants an assurance from the Shire of Peppermint Grove that legal action by the Cottesloe – Peppermint Grove Bowling Club against the Shire will not compromise the project.

"Combined with poor office accommodation...we may well lose not only more staff, but the momentum that has been built up over the past five years, as knowledge disappears from the organisation.

According to the report, Cottesloe's offices rank alongside Nedlands and East Fremantle as worst in the region.

Mosman Park and Claremont have just completed expansion/improvements. Neighbouring councils are all considering improvements, as 'added demands placed on local governments is evidenced by the expansion of office accommodation in the western suburbs.'
