"For some time Town staff have driven six-cylinder cars, and we have kept them for only a year," said CEO Steve Tindale. "Various financial incentives, discounts and tax exemptions encouraged this practice. # Liquor licensing please consult

WA's NEW liquor licensing laws, generally designed to allow more, smaller, outlets to sell alcohol on the premises are already taking effect in Perth. In Cottesloe, Blue Waters on Marine Parade was to the fore, gaining permission to serve drinks to customers without food.

To stay in touch with current trends, Cottesloe has developed a Liquor Licensing Policy, and now requests residents comments and opinions. Please submit your comments as soon as possible; closing date is Wednesday, September 5.

The Liquor Licensing Policy has been developed after perusal of similar legislation in WA and South Australia. In operation, it planning would cover approval for licensed premises, and any licence or permit referred to Cottesloe by the Dept of Racing and Gaming and Liquor (including the new 'liquor without a meal' extended trading permits.) It is intended to guide Council, inform applicants and protect local amenity.



COUNCIL is calling for public comments on the future of the Civic Centre's Lesser Hall. Used for a variety of public meetings and events, the Lesser Hall stands just inside the grounds off Broome Street.

Because of pressing need for more office space for Town at the Centre, Council is considering whether to allow private caterers the use of up to 30 per cent of the main hall area

Moving the caterers from their present location in the main building will provide space for more and improved administration offices.

# Jarrad Street closed – for 21 years

**PUBLIC** safety and Council liability have always been the considerations driving the long-running Jarrad Street saga.

After another round of public consultation - the third in five years - the Town has closed Jarrad Street between Marine Parade and the roundabout at the Sea View golf club entry.

The most recent consultation was required because Cottesloe was unable to spur the WA Planning Commission into action for permanent closure of the road. In consequence, Council used its own power to impose a temporary closure - of 21 years – and this required more public consultation. Outcome of this round was:

In favour of closure -245; Against – one.

### Sandtrap?

The made road from the roundabout down to Marine Parade will now be removed and backfilled with sand. All the existing 'road closed' signs and other treatments will be removed and new kerbing installed.



Signs will be removed and new kerbing installed at each end of the closed section of Jarrad St.

## **Design agreed**
