



## SHARK BARRIER FUNDING WELCOME

The Town has welcomed the news that the State government will fund the cost of a replacement shark barrier for Cottesloe beach, now that the original barrier has reached the end of its useful life.

Cottesloe was an early adopter of this form of shark mitigation, with the Town meeting the full cost of installation and maintenance over the first five years. The shark barrier at Cottesloe Main Beach has been hugely popular every summer since it was first installed. The State's contribution to peace-of-mind swimming is welcomed by the Cottesloe community and the many hundreds of thousands of visitors we welcome to Cottesloe beach every year.

## SEA VIEW GOLF CLUB - CONSULTATION

At the April 2024 Ordinary Meeting, Council resolved to engage the community to gather feedback on the Town's Sea View Golf Club (SVGC) club house redevelopment. The club house is in need of upgrade and presents an opportunity to deliver greater amenity for golfers and for other members of the community. Feedback will allow Council to understand what our community wants in terms of outcomes and complementary uses for potential inclusion in the redevelopment of the facilities.

## GREEN INFRASTRUCTURE STRATEGY - CLOSING SOON

There is still time to have your say on the Town's Green Infrastructure Strategy. Thank you to everyone who has already provided their feedback. The online survey is available at Engage Cottesloe (<https://engage.cottesloe.wa.gov.au/>) and is open until Sunday, 25 August 2024 (11pm).

The Natural Areas Management Plan and Street Tree Masterplan form part of the Strategy. If supported, the Strategy could lead to Council adopting policies to protect trees on private property. The Street Tree Masterplan includes how we deal with the replacement of Norfolk Island pine trees, as they fail – through age or by reason of disease. These issues have been the subject of discussion within the community and residents are encouraged to review the documents to find out more information and to have a say. If required, a hard copy of the survey is available from the Town's Administration office.
