7.1 Marine Parade Shared Path Upgrade (Curtin Avenue to North Street) – Draft Community Engagement Plan

SUMMARY

The Active Transport Working Group (ATWG) is asked to:

- Provide feedback on the proposed information that will be contained within the survey preamble and the consultation terms of reference for the Marine Parade Shared Path concept (attached) funded through the Federal Active Transport Fund; and
- Workshop and provide guidance on the aspiration survey questions pertaining to providing a safe on road cycle environment along Marine Parade.

The feedback provided will then be used to develop a Community Engagement Plan that will be circulated amongst elected members and the working group for comments.

BACKGROUND

- January 2025 The grant application was submitted;
- March 2025 The Town was informed of the successful outcome;
- April 2025
 - A public tender was advertised for the detail design of Marine Paraded Shared
 Path Upgrade Project;
 - Council endorses the draft Concept plan for community consultation reflecting several project scopes. The April Council's resolution can be found via the following link: https://www.cottesloe.wa.gov.au/council-meeting/22-april-2025-ordinary-council-meeting/358/documents/unconfirmed-minutes-ordinary-council-meeting-22-april-2025.pdf; and
- May 2025 Element was appointed the community engagement consultant.

OFFICER COMMENT

- Preamble Statement of Intent
 - Proposed concept follows the current path alignment and will be widened by 2m to provide a 4m wide path;
 - Creating a separate path will result in 1800m2 of green space lost and will result in \$2 Million of asset management implications associated with the routine maintenance and future renewal at the end of its useful life;
 - Other impacts include the loss of parking bays depending on the alignment of this segregated path
- Proposed questionnaire structure
 - o Demographics data (age, gender, address, use of path and employment status)

- Part 1 Marine Parade Shared Path Concept Consultation
 - This will be broken down into 3 sections:
 - Stage 1 South of Forrest Street (Curtin Avenue to Forrest Street)
 - > Stage 2 North of Napier Street (Napier Street to North Street)
 - Stage 3 Foreshore Precinct (Forrest Street to Napier Street)
 - The following public opinion will be obtained:
 - Level of support the alignment
 - Whether it enhances safety for all users
 - Whether it improves accessibility and usability for all ages and abilities
 - Are there any other considerations to improve user experience
- o Part 2 Marine Parade On-Road Cyclist Environment Improvement Aspirations
 - This is a workshop item with the working group to obtain guidance
 - Initial thoughts on-road cycle lanes, raised plateaus
 - Feedback received will be used to develop this section of the survey

The anticipated timeframes are as follows:

Circulation to Council for comments 6 to 9 June 2025
 Public Consultation Period 16 to 30 June 2025

• Council Endorsement July 2025

- Concerned about Stage 3 Middle section to make mention that the current path will still be there for use
- Eric St section/ connection may need to have 2 options
- What can be changed and what is informing only
- All one colour or 2 colours

Shaun Kan

• SK – DoT advised we are contrained to a Red path

Cate Patterson

- Eric St shared path connection needs to be a high priority
- Make sure to show eric st shared path conection on any plans in consultation

Cr Sadler

- Increase green spaces and remove conflict at path entrances
- Would pictures /options be good with examples
- What does the community envisage
- The principle to intergrate with the foreshore masterplan in this area
- Needs to follow the current alignment of the path but this NCSLS could be open to changing
- The principles to intergrate with the foreshore masterplan in the NSLSC area but the design may need to change from the current path alignment
