8.1.1 COMMUNITY DEVELOPMENT OFFICER UPDATE

Ms Jodee Harley advised the following:

- Attending the Lighthouse Project Workshop Dept. of Communities;
 - How to make a workplace disability friendly
 - Presentations from Disability Employment Service Providers
- Lighthouse Grant Program 2019;
 - \$10k with a Local Government contribution of 20%
 - Funding disability awareness training or engaging the wider business community on community disability employment
 - Education aimed at making businesses more user friendly with a focus on employment – employing people with disability
 - Funding is not for the provision of physical access but could possibly fund an accessibility audit
 - Opens in the next month or two

The committee discussed how to gain interest and encourage local businesses to undertake training. Future need to look at how businesses can improve their capacity to improve access for customers and to potentially employ people with a disability.

Ms Jodee Harley advised the following:

- Targeting Club Managers how to make the clubs more inclusive for volunteers with a disability


- Retro fitting has difficulties door widths

A need was identified for new bays to be installed at the Cottesloe Tennis Club, Seaview Community Kindergarten and the new Coastcare Nature Walk in South Cottesloe.

Cr Sadler introduced this item explaining that due to an absence of quorum for the April workshop it did not go ahead, because of this a priority list for 2019/20 was developed from the Disability Access and Inclusion Plan by Cr Sadler and the administration with the committee's objectives in mind.

Cr Sadler advised the 'Most Accessible Business Awards' would come to the committee as a separate item for discussion in the coming months.

The committee discussed increasing membership of the Disability Services Advisory Committee at length;

- Seek to gain interest from other similar organisations within Cottesloe
- Look at ways of engaging with those in the community that deal with accessibility issues due to a disability
- Potential to build a stakeholder database of people who want to be involved in solving issues but not necessarily want to be part of a committee

Cr Sadler also advised that should the Budget be adopted money has been set aside for upgrades to ACROD bays; a Traineeship for someone from the Town of Cottesloe with a disability; and potentially beach matting to improve accessibility at the groin.

Community Development Officer Ms Jodee Harley spoke about the need for people with disability knowing how to find there way around Cottesloe. The committee discussed investigating the development of Cottesloe access map/video with the City of Bunbury highlighted as a starting point with reference to their initiative MARCIA.
