8.2 ITEMS FOR DISCUSSION

8.2.1 WALGA ROAD SAFETY UPDATE

Ms Celenza provided the Committee with an update on the following:

- The death toll on Western Australian roads has been higher than the past few years. There have been 132 deaths in total this year with 58 deaths occurring in the metropolitan area. There were 121 deaths in total this time last year.
- The Road Safety Strategy is open for comment and is available on the Road Safety Commission website.
- A crash data report has been generated covering the Western Suburbs.

8.2.2 POLICE UPDATE

S/C Matthews provided the Committee with an update on the following:

- In a two month period the following crimes have been recorded:
 - 17 stealing from motor vehicle. Predominately rental cars. Police have contacted the rental companies requesting information on preventative measures that can be provided to renters.
 - Five vehicles in Grant Street had items stolen resulting in \$1,500 in damage.

- Five burglaries reported.
- Nine stealing offences reported.
- One instance of graffiti reported.
- One instance of stealing reported at North Cottesloe Primary School.
- Information regarding speeding on Broome Street was passed to State Traffic for action. Area was monitored.

8.2.3 RANGER UPDATE

Ms Squiers provided the Committee with an update on the following:

- Extra casual Rangers have been rostered for the summer season dependent on the weather.
- CCTV has been installed in Napoleon Street and Jarrad Street.
- Western Power has contacted the Town requesting infrastructure (CCTV, parking systems) on their poles be removed.
- Body cameras to be purchased for Rangers to wear as part of their uniform.
- There has been an increase in homelessness in the Cottesloe Central Business District.
- Homeless camps/squats have been removed from along the railway.
- No reports of snakes as of yet.
- Cyclists on the Principal Shared Path are not slowing down at level crossings.
- Attended the Community Safety Network Conference.
