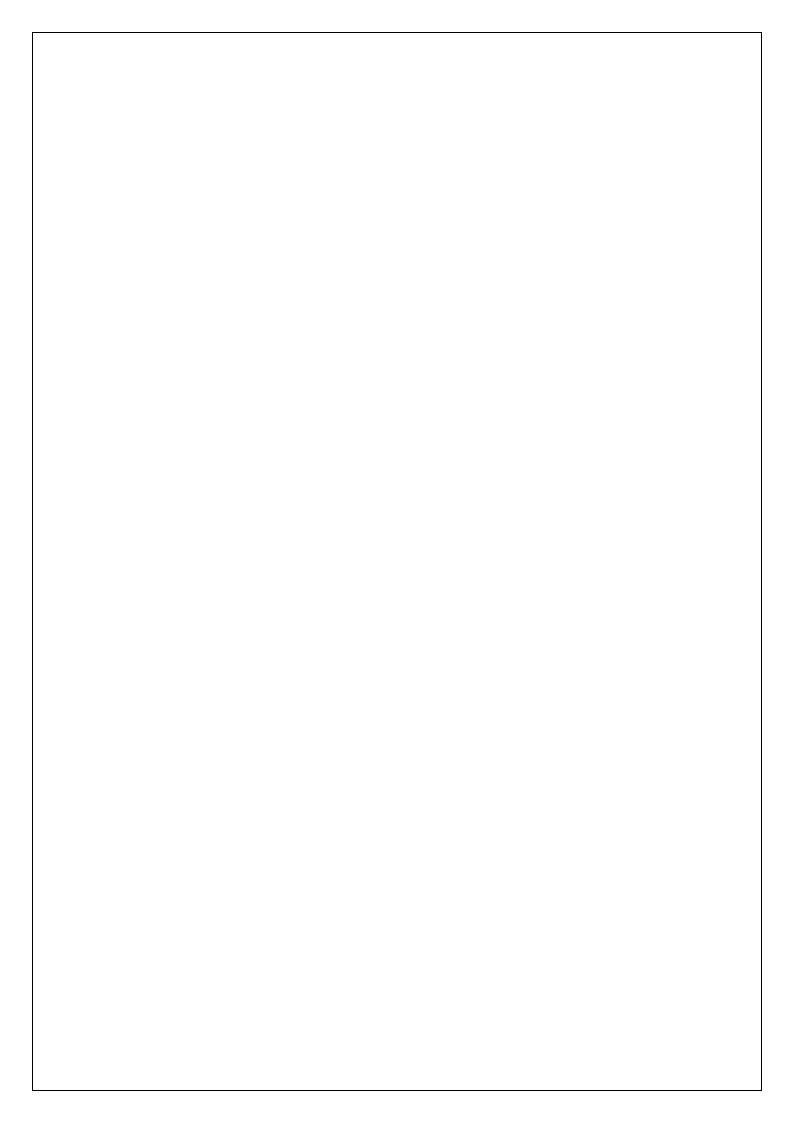

#### **SUMMARY**

A proposed site layout for the "She Sells Sea Shells (SSSS)" sculpture at Vlamingh was presented to the 10 October 2019 Arts Advisory Panel (AAP) Meeting, the design was then finalised following a site meeting with panel members and the sculpture artist.

The Committee is asked to recommend the attached design for Council's approval including a budget variation of \$10,000 for the installation works.

#### **BACKGROUND**

At the 10 October 2019 Meeting, a draft concept providing an indication on the sculpture alignment, footing and fencing was presented by the Chief Executive Officer (CEO) to the AAP Meeting.

The CEO confirmed that:

- A new Cottesloe entry sign will be installed at the lowest permitted height 1300 millimetres;
- A new fence made from low key natural material to suit the surroundings aesthetically will be installed along the slope edges within the site to keep the dunes separated from bikes and pedestrians;
- Engineering would have no concern in moving the footing to the north, south or west of the location indicated on the presented plan;
- A surveyor will peg out the site for the Panel to review and finalise;
- The no stopping signs will be removed and replaced with yellow lines if required.

A site inspection was conducted with the artist and the panel presiding member on 21 October 2019 whereby the following changes were requested and updated on the attached plan:

- Sculpture moved 1.2metres North along the marked out line;
- Seating installed to South Western base just before the start of dune, on the axis from midpoint of two 40kmh signs on Curtin Ave through centre point of artwork based on the above revised location;

- Fence to NW of sculpture ideally low or non-obtrusive;
- "Town of Cottesloe" sign lowered to open views to site, possibly with "Thank you for Visiting the Town of Cottesloe" on its reverse side to feature in photos of the sculpture.

#### **OFFICER COMMENT**

Several locations within the Vlamingh site were considered for the SSSS sculpture at the 5 September 2019 AAP Meeting. The position of the sculpture shown on the attached drawing was deemed to be the best location as this provided a level and accessible site, befitting for a Town of Cottesloe Entry Statement. The artist is supportive of the location and will also be consulted to determine the final orientation of the art work.

The art work is currently stored securely at the Stack Street Depot in Fremantle. It is preferred that the sculpture be relocated before the Operations shifts to the new facility at the Town of Mosman Park in February 2020.

However, the installation costs have not been budgeted in this financial year and an amendment would be required to undertake this installation within the preferred time frame.

Accordingly, a recommendation will be made for the Committee to accept the attached the proposed design and support the required \$10,000 budget amendment for Council's approval. Both the Committee and Council are asked to note that the additional funds required will be sourced through cost savings within the 2019/2020 Capital and Operational Budgets such that the Council approved budget for this financial year remains unchanged.

The CEO advised that Councils strategic, legislative and policy documents reside in their appropriate areas on the website as to have them over multiple pages can cause a raft of issues when reviews and updates are undertaken.

#### 9.1 COMMITTEE MEMBERS

 Cr Tucak – Council deferral of recommendation to amend point 4 of the Art Acquisition Policy – Council requiring further information regarding 'no restrictions be place on donations'

The CEO advised that an amended recommendation can be returned to Council with a clear rationale.

Cr Harben advised that she had found the appropriate wording for use in the amended recommendation – Source: The Museum of Tweed NSW.

The Committee developed the following recommendation which will be presented to Council early in 2020, with a rationale yet to be developed by Ms R Sadler and Cr Harben.

The PAAC recommend to Council

That as soon as possible an addition be made to the Acquisition of Arts Policy at the end of clause 4.3(n)

"The Town does not accept conditional donations. In some cases the proposed donation may be eligible for tax donations under the Culture and Gifts Program which encourages gifts of significant cultural items to public art galleries, museums, libraries by offering donors a tax deduction of up to the market value of their gifts, under Subdivision30-A of the Income Tax Assessment Act of 1997".

2. Cr Tucak - Take 3 for the Sea – Artwork for beach path

Council has requested that the committee better articulate rationale for previous recommendation (to not support the artwork).

CEO will bring a report back to the committee – report will cover the entire deferral, committee can work on developing the rationale in the meantime.

- 3. Mr S Mellor Tabled a 1 page document titled 'Discussion items remaining from AAP add to action list?' Mr Mellor then enquired of the CEO as to the status of some of the items on the list, namely;
