


HAPPY HOLIDAYS

As part of the Public Open Space and Playground Strategy, adopted by Council in 2019, the Town is seeking feedback from our community on what they would like to see in a playground upgrade in East Cottesloe. The East Cottesloe playground space extends from the Purple Dinosaur playground on Railway Street to the playground opposite Albion Street.

PARKING IN EAST COTTESLOE

To address an expected surge of vehicles (estimated at up to 250 per day) associated with the large development currently under construction in the Town of Claremont at 1 Airlie Street (The Grove Residences), Council resolved at the October Council meeting to implement temporary parking restrictions in East Cottesloe, from Forrest Street to Eric Street including the railway reserve.

These measures have been put in place after careful consideration of all options. Council has adopted an approach that will allow residents in this area to park authorised vehicles on-street at all times, while restricting parking for non-residents. A letter has been sent to residents in the area advising them of the changes. An application form for authorisation permits has also been sent to all residents in the area.

Signage has been installed and a two-hour parking restriction applies to vehicles that do not display a permit. Restrictions apply from Monday to Saturday, 7am to 5pm.

INDIANA TEA HOUSE

Following the announcement made by Tattarang last weekend about plans for the Indiana site, we would like to provide a response from the Town.

Over the past year or so Council and the Town's Administration have engaged in conversations with the Lessee (now represented by Fiveight) about the future of the Indiana site. At the request of the Lessee, these conversations were confidential.

Since July this year, Council has pressed Fiveight for a formal proposal so that future plans for the site could be progressed in the public realm. A proposal was received by the Town on Friday, 26 November and an Elected Member briefing was held on Wednesday, 1 December.

The Town's Administration will present a Report on the matter, to be considered by Council at the 14 December Council Meeting.

We now welcome the opportunity for open and public conversations about the future of Indiana's.
