PUBLIC OPEN SPACE WORKING GROUP

PURPOSE

The purpose of this Working Group is to consider improvements to all public open space outside of the Central Foreshore Precinct and the SVGC/Harvey Field Recreation Precinct provided by the Town which will enhance their use and enjoyment by the community.

TERMS OF REFERENCE

- a. To advise Council on infrastructure and policy requirements to improve all public open space provided by the Town (outside the of the Central Foreshore Precinct and the SVGC/Harvey Field Recreation Precinct); and
- b. Make recommendations to Council on matters relevant to the Committee.

7 REPORTS OF OFFICERS

7.1 EAST COTTESLOE PLAYGROUND - CONCEPT DEVELOPMENT

SUMMARY

The working group is asked to discuss the visual summary with Nature Base Play, the appointed consultant and provide feedback on various aspects raised at the November 2020 for a concept to be developed and approved by Council for public consultation.

BACKGROUND

At the November 2020 Meeting, the working group:

- Agreed with the three phased approach to the project
- Accepted the visual summary for the East Cottesloe Playground developed by Mr Powell, the aspiration of the working group that would still need to be put out to public consultation
- Supportive of the consultation catchment reflected in the draft engagement plan provided then
- Requested for a meeting with the consultant after DPLH had approved the cash-inlieu expenditure to provide the playground designers feedback on:
 - The area's character and scale of playground envisaged for the space
 - Imagery that will needed for the public consultation sandpits, footpath material, pump tracks, mother with prams, flying foxes, basketball, netball, table tennis, benches, and picnic tables etc

OFFICER'S COMMENTS

DPLH through the Minister for Planning has since approved the \$340,000 for the upgrade to this playground and Council has adopted a corresponding amount in it's 2021/2022 budget.

Nature based Play have been appointed as the consultants for the design works

Completion of the above would then allow the consultant to develop a concept for adoption by Council to go out to public consultation.

Depending on the outcome from the meeting, the attached project and engagement plan will then be updated and distribution to the working group. This has been provided to this meeting for the purpose of discussions.

INTENDED OUTCOME FROM MEETING

- (1) Introduction of the Nature Base Play
- (2) Provide feedback on the area's character and scale of playground envisaged for the space

- (3) Images of space activation that will need to be included in the concept for Council's approval for wider public consultation (as per the November 2021 notes)
- (4) Agree on timeframes to produce deliverables

MEETING NOTES

Cr Harkins introduced this item and handed over to Mr Kan, Director Engineering Services. Mr Kan advised that since the agreement of the working group of project principles and visual summary in November 2020 the Department of Planning, Land and Heritage have approved the \$340,000 for East Cottesloe Playground and Nature Based Play have been appointed for the concept and detail design.

Mr Kan advised that the purpose of today's meeting is:

- 1. Meet and Greet the consultant;
- 2. Working group to provide feedback on matters in point 4 in the project background;
- 3. Agree on timeframes moving forward
 - a. Develop imagery to support public consultation (2 weeks) Images from Nature Based Play to be used in survey and to be emailed by 5 October;
 - b. Timing of public consultation 1 November to 12 November 2021
 - c. Consideration of consultation feedback by Nature Based Play
 - d. Development of concept for council's approval including costings (2 months)
- 4. Agree on indicative duration for:
 - a. Detail design for Administration to determine tender and construction timeframes (6 weeks)
- 5. A project plan will then be updated accordingly and sent out to the working group.

Angus from Nature Based Play had a couple of questions:

- 1. Is the group aware of any local history for the site? (this could be a question in the survey?) Nature Based Play to incorporate any history if applicable.
 - a. The Railway and coal were mentioned by working group members.
- 2. Images for the consultation?
 - a. Images to be provided based on the engagement plan for the consultation survey Nature Based Play to provide. The draft engagement plan detailing the required images is attached.

Cr Harkins opened the discussion to the working group and the below points were noted:

- Check with Department of Transport whether they would fund pump track or skills track? Administration to check and Cr Barrett has offered to provide emails from 2019 should this be required to follow up with DoT.
- 13-17year old area suggested lay infrastructure : basketball, table tennis etc
- 6-13year old area CEO asked whether it would be more sensible to place this
 closer to primary school, noting that (0-6) would already be in a current enclosed
 area. The working group discussed this suggestion and were comfortable for the
 current layout to remain given the under 6 year olds will be predominantly
 fenced off using the current barricades on site.
- Skills track position on the plan falls within the railway pedestrian crossing and due consideration would need to be given to ensure pedestrian safety is not compromised.
- The working group has asked for the purple dinosaur play area (sand pit & soft fall) to be retained.
- Pump track natural look rather than concrete. (stabilised & compacted dirt)
- Gates and services onsite have been resolved
- Footpath linking all areas to be of material similar to compacted limestone that can be used by prams & bicycles
- Soft Landscaping consideration to be given to nature sensory garden/ bush tucker (no vegetable garden)
- Retain as much as possible of what is already existing to keep to budget
- The working group discussed the possibility of a flying fox but have been advised by Nature Base Play that such an infrastructure takes up too much space and may not fall within the budget of the project
- A request was made for the visual summary plan to be attached to the minutes
- A request was made for a dual use drinking fountain that incorporated a dog bowl at the bottom of the device
- Benches and Tables Include an area to sit and gather for the neighbours
