

Town Centre Plan updated

COTTESLOE has updated its planning for the Town Centre. Staff will now begin detailed design and feasibility assessments, including land assembly and approval procedures.

This month officers reported on:

- Conversion of the Station Street sump site into a surface car park for public shopper parking, time-managed using the Meter Eye system; and
- Investigation of a surface car park primarily for permit-managed worker parking on the Government landholding at the southeast corner of Jarrad Street and Curtin Avenue, with the design retaining all existing trees on the site.

Also, consultants will prepare a more detailed design for public domain improvements to Station Street based on the Town Centre Public Domain Infrastructure Improvement

This takes into account the sump site project, crime prevention measures and possible future development of the Council car park and private properties. Interested parties will also be consulted.

ful grant application to the Office of Crime Prevention, officers will continue to investigate CCTV in Station Street and the Town Centre, as a priority crime prevention strategy.

The consultants will also prepare more detailed designs for improvements to the network of lanes and walkways in the Town Centre.

Disability Services Advisory Committee

THE next phase of action towards revitalisation of the Cottesloe foreshore has been considered by the Council. The development plan is the basis for consideration of all proposals, large and small, by the Council as primary custodian of the area.

Ideally it will also be acknowledged by other decision-makers such as the Heritage Council of Western Australia (HCWA) and the Western Australian Planning Commission (WAPC).

Premier support

In May Premier Colin Barnett wrote to Cottesloe Council stating that revamping of the foreshore is needed and if the price tag is \$15 million then it does become a realistic project.

"As the local MP I would be pleased to pursue joint funding and to assist; there may be some scope for sale of land," he wrote.

Land sales can fund foreshore development

With this positive indication from the Premier the Council can respond by firming-up proposals and submitting a formal request for funding.

The suggestion of possible scope for sale of land is an invitation for both the Town and Government to explore what land may be a feasible source of revenue to be applied to the fore-

In August officers reported to Council on specific

aspects of the plan. They have now been asked to: investigate de-

tailed design guidelines for

high-quality buildings; prepare a guide for temporary closure of Marine Parade, for major events, and the feasibility of realigning Marine Parade; look at ways to downscale Car Park 1 and improve of Car Park 2; and investigate other parking improvements in the area.

Staff will also seek a quantified financial contribution from the State towards the plan; research specific funding for cycle facilities; and report on potential land in the district, held by the Town or State which might be sold to raise funds for the foreshore redevelopment.

Council 'Yes' to Cash for **Containers**

A SCHEME that would boost WA's overall recycling rate has gained support from Cottesloe and other local governments.

Currently, our recycling rate is one of Australia's

lowest, at just 32%. In comparison, national leader South Australia recycles more than 70%.

Deposits on containers have been in place for more than 30 years in South Australia.

Although a national Cash for Containers Scheme has been discussed for years there appears to be no certainty of it being implemented.

But WALGA - WA's Local Government Association – plans a campaign to advocate a Cash for Containers scheme here in WA.

The Council has said it will support a State Cash for Containers Scheme, and will take part in or sponsor a Cash for Containers event during September, October or November.

Black Spot

COTTESLOE has accepted a \$90,000 State Blackspot grant from Main Roads WA for the construction and lighting of crossing islands on Curtin Avenue, opposite the Mosman Park railway station, near Princes Street.

The Town will provide a \$45,000 contribution and undertake the works during the 2012/2013 financial year.

Child care

COTTESLOE will allocate \$20,000 to assist landscaping the Marmion Street Pre-Primary site ready for its occupation by the Cottesloe Child Care Centre.

NEW regulations require local governments to prepare a Strategic Community Plan, that guides the remainder of their long term planning documents.

As a preliminary step, Cottesloe has appointed consultants to undertake a community perceptions survey.

Playtime on the verges

AFTER lengthy consideration, study of similar situations in other council areas, and legal advice, Cottesloe is introducing a special permit for Road Verge Structures, with provisions for minimising public hazards. No play equipment will be approved for installation on a verge or attached to a street tree in Cottesloe, unless a submission is made to the Council and a permit issued.
