RTG - do we join?

SHOULD Cottesloe join other local councils in a process that could lead into a Regional Transition Group? That's the question facing the Council, and once again opinions from the Town community are sought.

The concept of amalgamation has advanced since the last time residents' views were requested.

Specifically, after looking at submissions by western councils, the for Local suburbs Minister Government, John Castrilli, wrote to Mayor Morgan requesting that Cottesloe, with other local councils, should start the process of Regional forming

Transition Group (RTG). Mayor Morgan:

"The Council discussed this at great length and agreed numerous conditions should apply before we moved forward with an RTG.

"Paramount among these is prior consultation with our local community, and that is already well under

Online

Full information about the RTG process went online at the end of March.

Included is a straightforward feedback form, asking for comments on a short range of options.

Partnership

On March 22 Cottesloe Council received a report recommending that a desirable partnership would be with Claremont, Mosman Park and Peppermint Grove. Since then, some of those Councils have voted against proceeding into an RTG process.

The feedback form on the Cottesloe website takes account of these decisions.

Comments

Cottesloe has outlined conditions to be met before proceeding further. As stated by Mayor Morgan, community consultation is prominent among them. Local residents need to be well aware of these conditions - summarised here so they can make the most informed comment on whether the Council should proceed.

The Council has advised the Minister that Cottesloe is willing – with conditions – to enter into the RTG process as far as stage one the development of a Regional Business Plan. Cottesloe would then review its position based upon the outcomes of that plan.

Mayor to speak on RTG at SOS meeting

AN extra opportunity for community interaction on the RTG issue comes at the AGM of SOS Cottesloe, on May 3. At the meeting in the Lesser Hall of the Civic Centre, Mayor Kevin Morgan has been asked to talk about the structural reform and Regional Transition Grouping. Everyone is welcome to attend the AGM.

Conditions

1/ The Town will not formally enter the RTG until the community has been consulted.

2/ If councils involved in the RTG process decide NOT to proceed, they can instead adapt the Business Plan for use by a regional council.

3/ Within the Business Plan, the Civic Centre, grounds and the War Memorial Town Hall, will be preserved as a community asset accessible to the general community.

4/ Amalgamation will not cause any forced redundancies of Council staff.

5/ The Minister will notify the Town of levels of state funding for development of a Regional Business Plan prior to any agreement.

Which councils?

Our Council has stated that it would consider joining with the Towns of Claremont, Mosman Park and the Shire of Peppermint Grove to form a Regional Transition Group.

Also, it has requested that the Minister support and approve the boundary adjustments (as resolved by

the Council in September 2009) as part of the RTG, to include the communities of Swanbourne in the north and North Fremantle in the south.

Representation

However, before confirming its final intentions, the Council will reaffirm the community's support for entering into a RTG.

The Council has also told the Minister that:

- the Mayor should be the member of the RTG Board and the Deputy Mayor the deputy member of the Board.
- the negotiated RTG Agreement should be submitted to Council for endorsement prior to it being executed on behalf of the Town.
- the RTG agreement should incorporate scope to include a Regional Business Plan with boundary adjust-

• the RTG agreement should incorporate an agreement for elections prior to the start of any new local government.
